Subject : "Desh Ka Prakriti Parikshan Abhiyan" – reg.

Madam / Sir,

Under the "Desh Ka Prakriti Parikshan Abhiyan," many Teachers, Medical Officers, and Postgraduate Students carried out Prakriti Parikshan by using the Volunteer /practitioner category login. The Prakriti Parikshan done by these Vaidyas are to be linked with the respective colleges for rating purpose.

Additionally, due to the non-updating of college codes for certain teachers, their work has been erroneously linked to their previous colleges. The concerned colleges are required to submit the details of these teachers and medical officers, including their name, current college name, college code, mobile number, and teacher code. This information must be sent to dpp.helpdesk@ncismindia.org not later than 04 January 2025.

In addition to this, several colleges have requested an extension to complete the required number of Prakriti Parikshan for their ratings. In light of these requests, it has been decided that all Prakriti Parikshan conducted by colleges until 31st January 2025 will be considered valid for rating points.

During this additional time, colleges may achieve their objectives. The Commission has not set any specific targets for this purpose, allowing colleges to establish their own goals as per their convenience. At the same time, it is advisable not to impose any numerical bindings on the students.
